Privacy policy for Sponsorship at Software Testing Forum 2022

This privacy policy specifically governs the collection, storage and use of personal information collected by us, Associazione ITA-STQB, via our websites at

ecomm.ita-stqb.org and www.swtestingforum.org

(generally indicated as "Website") during registrations and during events dedicated to Software Engineering professionals and that we provide to the Sponsors for marketing purposes after the event in the execution of contracts with sponsors and partners of the event.

Please read this privacy policy carefully and sign it for acceptance.

This privacy policy was updated on March 1st, 2021.

1. Data Controller

Associazione ITA-STQB is a no-profit company registered under Italian law with registration number BS - 507084, and with its registered office at via Brozzoni, 9, 25125 Brescia, Italy.

We will only process collected personal information in accordance with the General Data Protection Regulation (Regulation 2016/679) on 25 May 2018 ("GDPR").

2. The personal information we collect and provide to the sponsors

Upon explicit consent of the subscriber, we are allowed to transfer the following data:

- Full name (first and last name);
- E-mail Address;
- Telephone number;
- Company name and the subscriber role in the company;

to the sponsors of the event for their marketing purposes. Our events are free access events, so in order to allow us to provide this service we need sponsors. In order to collect these sponsors and to be able to organize the event, we provide them the list of participants that gave us their explicit consent. We inform the subscribers in our Privacy Policy and specifically during registration, that we will transfer the above listed data to our sponsors for marketing purposes and that without the explicit consent to this data transfer we can not proceed with the registration itself, as the possibility of transferring the above data is necessary for us in the execution of contracts with sponsors and partners of the event and therefore fall within the legitimate interest of ITA-STQB in order to carry out the event. The sponsors of the event are clearly stated on the event website, so the subscribers

know to which subjects their data are transferred for marketing purposes. The sponsor must provide the possibility to unsubscribe from any marketing communications.

3. Authorization to use images and videos obtained during the events organized by ITA-STQB

For what concerns the events organized by ITA-STQB, the use and publication of videos and photographs and screen dumps (hereinafter referred to as "media") of the event are necessary in the context of the execution of contracts with the sponsors and partners of the event and therefore fall within the legitimate interest of ITA-STQB in order to carry out the event. ITA-STQB therefore requires all those who sign up for the event to provide explicit permission to publish media in which they may appear in person. The publication can be done on the websites of ITA-STQB, on the websites of the sponsors and partners of the event and on social networks (eg Facebook, Twitter, LinkedIn, Youtube, etc.). This authorization is mandatory in order to proceed with the registration to the event as without it ITA-STQB could not publish the media for the objective impossibility to identify the images of those who did not give permission to the publication, therefore it could not follow the obligations contracts to carry out the event.

4. Data retention

The Sponsor must apply a data retention policy that is in accordance with the General Data Protection Regulation (Regulation 2016/679) on 25 May 2018 ("GDPR").

5. Security

The Sponsor must take appropriate technical and organisational measures to safeguard the personal information that we provide about the people that attended the events, against unauthorized or unlawful processing and against accidental destruction, loss or damage.

6. Rights of the owners of the personal data

The Sponsor must ensure the following rights to the owners of the personal data:

- the right to access to own personal information;
- the right to ask the Sponsor to update and correct free of charge any out-of-date or incorrect personal information that the Sponsor holds;
- the right to withdraw any consent about the usage of personal data at any time, without affecting the lawfulness of processing based on consent before its withdrawal;
- the right to erase where the conditions of article 17 of the GDPR have been met;
- the right to restriction of processing where the conditions of article 18 of the GDPR have been met;
- the right to data portability insofar the conditions of article 20 GDPR apply;
- the right to object to processing of own personal data, insofar applicable under article 21 of the GDPR;
- the right to lodge a complaint with a supervisory authority; and

- the right to opt out, at first request and free of charge, of any direct marketing communications that the Sponsor may send.
